RULES AND REGULATIONS

RESERVATIONS: The deadline for all space reservations is March 1, 2017. The fee for a space is \$130 (early bird) by February 1st or \$160 by March 1st.

- No animals allowed at the Furnace Creek Inn or Ranch Resort.
- No food or drink sales of any kind are allowed in booths.
- Booths are to be manned both days for the duration of posted show times.

SET UP INFO: The show will be staged on the lawn in front of the Ranch front desk. Booths may be set up starting at Noon on Friday. Please be ready for sales by 9:30am on Saturday. Coffee and lunch will be provided. After using the registration parking for loading, please move your vehicle to the gravel parking on the other side of the General Store. **This courtesy will allow our guests better access to parking (and your work).**

POSTED SHOW TIMES: 10:00am – 5:00pm Saturday and 10:00am – 3:00pm Sunday.

SECURITY: Each participant is responsible for the safety, protection, and insurance of his/her own exhibit and merchandise. **No protection can be guaranteed.**

OVERNIGHT STORAGE: If staying at the Ranch, guestrooms are spacious and should more than accommodate any overnight storage needs for your artwork.

REFUNDS: No refunds will be issued once space has been reserved.

SPACE LOCATION: Spaces assigned based on safety regulations as well as aesthetics.

DEMONSTRATIONS: Demonstrations of your skills are encouraged. By witnessing your work in progress, customers develop a deeper appreciation for both the art and artist.
